




- Not Yet Aligned: Our data and sustainability goals are still like two puzzle pieces we're figuring out how to fit together

What is Data Mesh?

Everyone has access to the data they need to make NET POSITIVE decisions *a new approach to data architecture that decentralizes ownership of domain data; focuses on organizational scaling, not on technical scaling*

What are Data Products?

Shareable datasets that are published and discoverable by any team at Zalando.

Our goal is to enable Sustainability Teams to effectively discover, manage and steward sustainability data.



The Problem

SDPI deploys data products in 4 phases

2

Discovery

Solution Design

Implementation

Operationalization

The goal of the discovery phase is to identify key pain points between stakeholder groups and shape conceptual data products (KPIs)

Solution design provides data & tech teams with a detailed view of the requirements from internal/external stakeholders. Sustainability data are centralized and enabled on a BI tool, thus automating data collection & processing, sharing analyses, and providing a safe and secure single source of truth to store, find and extract sensitive data. 4

The operational objective is to embed sustainability data products within the general operations. Thus fostering stewardship, management of compliance and controls, and sharing of data products.


